Requirements:

California hunting license and upland game bird stamp required.

Pricing and packages subject to change without notice.

All sales are final.

Bird Card Guidelines:

• Conversion: 2 pheasant = 3 chukar (e.g., 3 chukar = 2 punches) • Minimum stocking per gun: 2 pheasant or 3 chukar

Bird Card Guidelines:

– Dec 31: 50% required usage – Feb 1: 75% required usage – Mar 31: 100% required usage (no exceptions)

Birds guaranteed for members through March 1; thereafter subject to availability

• Unused birds are forfeited; no carryover permitted • One punch equals one pheasant released

Additional Services:

Bird cleaning: \$7 per bird (includes professional cleaning, vacuum sealing, and ice)

Season: September 1 – March 31 Limited to stocked birds only

All membership dues must be paid in full before hunting. All stocked bird cards punched on a release basis. I hereby agree (ANTELOPE VALLEY SPORTSMAN'S CLUB) may make reasonable inquiry as to my character and financial status.

CLUB RULES AND REGULATIONS.

1. Club hours Hunting Pheasant. Chukar: Thursday - Friday 8:00 am - 2:00 pm Sat & Sunday - 8:00 am to 4:00 pm . Dove, native quail as prescribed by law. Game animals may be hunted during hours legal for game animals. Office hours for reservations, 7:30 a.m. to 6:00 p.m.
2. All persons hunting or not must check in and out at the club office. No exceptions.
3. You must check in all game you shoot. Leaving wounded game without an honest attempt to retrieve it, or discarding unwanted game will not be tolerated and will result in forfeiture of your membership. All game must have DFG seals or tags before you leave the club
4. All hunters, regardless of age, must have a valid hunting license and field pass issued at the office in possession at all times. No person without a hunting license will be permitted to hunt.
5. Guest privileges by prior reservations only. Please call or book online at least one day in advance.
6. Use of alcoholic beverages while hunting or other hazardous conduct by members or guests will not be tolerated and subjects members to forfeiture of membership privileges.
7. No person may have any firearms other than shotgun on property (including BB guns, air pistols, or cross bows) unless prior authorization is obtained. The use of firearms is restricted to designated areas only.
8. No vehicles in the fields at any time. You are to use designated parking areas only. This applies to all vehicles (pickups, 4 wheel drives, and motorcycles).
9. Motorcycles or 4 wheel drives may be used only as transportation to and from hunting and fishing. You must stay on designate roads; cross country travel is not permitted. All motorcycles must be equipped with Forest Service approved spark arrestor muffler.
10. Use of club before 7:30 a.m. is by appointment only. Call between 7:30 and 6:00. This is an absolute must.
11. All dogs must be kept on a leash except when hunting in the fields. We will not tolerate dogs running out of control in the field or around the club office area. No dogs in the club office, around bird pens or kennels at any time. Dogs may be used to hunt upland game birds only.
12. It is a violation to pluck or draw birds in the fields, or to litter the fields with bottles, cans, etc. Trash cans are provided in designated areas. Bird cleaning facility hours are: 9:00 a.m. to 4:00 p.m. daily.
13. Absolutely no hunting in closed areas or within 150 yards of livestock, vehicles, or buildings.
14. No smoking in hunting fields or on sporting clays range.
15. Hunters and dog handlers: if your bitches are in season, please leave them home!

A violation of Fish & Game laws or regulations and/or unsportsmanlike conduct may be grounds for membership forfeiture.
